





 - The W-IdNr. is intended to combine the commercial tax numbers, some of which applied only to individual types of tax, and make them clearer.
 - The W-IdNr. will have the same format as the VAT identification number with the letters DE and another 9 digits. Companies that already have a VAT ID no. have to use them as an economic identification number after the entry into force.
 - For the assignment of the W-IdNr. the Federal Central Office is responsible for taxes.
- 2) USt-IdNr. (Umsatzsteuer-Identifikationsnummer)**
 - The VAT ID no. is a unique identification of a company within the European Union in the sales tax sense.
 - The VAT ID no. of a company based in Germany always starts with DE followed by a block of 9 digits (z.B. DE999999999).
 - For the assignment of the VAT ID no. the Federal Central Office is responsible for taxes.
- 3) St-IdNr. (tax number)**
 - The St-IdNr. is an identification number issued by the tax office to every taxable person (natural or legal person) under which the person or company is managed at the tax office.
 - The St-IdNr. is already assigned to a taxpayer. The tax number is of central importance for all administrative processes within the tax authorities.
 - The St.-Nr. is composed differently depending on the federal state.
